1) **Call to order** – 2:33 P.M.

2) Approval of agenda

Short stated that for the awards above, BUSE 150 was moved from the list of Business/Business-related courses to the courses required for the major in response to the advisory's board recommendation for a soft skills course, which would address a lack of soft skills seen in new hires. Furthermore, CBTE 180 was added as an option to the courses required for the major in response to another recommendation from the advisory board for courses in which students will be able to be familiar office computer applications.

3) New business

- a) Removal of duplicate list of ADTs in catalog
 - D. Short stated CIC has recommended the removal of the list of ADTs within the catalog (page 110 for the 2019 – 2020 version) since there already exists a list of degrees and certificates (pages 136 – 141) which include ADTs.
 - ii) The committee agreed to the removal of the list of ADTs.

4) Old business

- a) Proposed new subject area: Lifeguarding (LFGD)
 - D. Short stated the new subject area, LFGD, has been approved and entered into CurricUNET. All affected FIPT courses have started to be converted to LFGD. The first few proposals will be reviewed at the next Curriculum Technical Review Subcommittee meeting. The certificates and degree will be transferred over to a new program area.

5) Reports

a) Vice President of Instruction

- P. Hopkins attended the Fall 2019 California Community Colleges Chief Instructional Officers Conference. She stated the focus had been on equity and how the schedule and programs should be developed and delivered through an equity lens and deficit mindset.
- ii) With the community colleges receiving less apportionment for courses scheduled less than 16 weeks, the Chief Instructional Officers are lobbying at the state level since the community colleges are not receiving the appropriate funding despite heeding the state's findings and following their recommendations.
- b) Evaluator None.
- c) Articulation Officer
 - M. Sanft stated the Articulation Officers receive reports from the universities regarding their new programs. The CSUs are looking to possibly implement an Ethnic Studies course as a graduation requirement.
 - Every fall and spring term, the Articulation Officers gather at the state level to discuss current themes and emerging initiatives. At the time of the conference, there was discussion regarding auto-awarding ADTs, but it has now been vetoed.
 - (1) The committee discussed the issues that arise with auto-awarding ADTs (e.g., argument for admission into the college for a specific major, affecting financial aid status, units of separation for multiple degrees).
 - iii) A pilot for Credit for Prior Learning is currently happening at Miramar College in the Automotive department.
 - iv) It was rumored that the CSUs attempted to reduce the number of units from six to three for the American Institutions requirement but there has been no further conversation about this.
- d) Curriculum Chair
 - i) 2020-21 catalog production
 - (1) D. Short stated the District will produce a limited number of catalogs for the 2020-2021 year. However, moving forward, the District's Catalog Committee will try to migrate to an interactive, online catalog.
 - (2) The CurricUNET Steering Subcommittee is in the midst of looking for a replacement to our current curriculum management system. Ideally, this new platform would generate a catalog.
 - ii) Units of separation for multiple degrees
 - (1) D. Short stated the issue regarding the number of units of separation had been presented a second time at the Academic Senate meeting. The members voted for six units. D. Short notified Mesa and City College and stated if the issue arises once more at CIC, he will advocate for six units.
 - (2) All three colleges agreed there would zero units of separation for ADTs. However, District Student Services did not agree with the rule stating it is not equitable since those earning non-ADT awards are being held to the six units of separation. Vice Chancellor Lynn Neault and the three respective Curriculum chairs discussed the matter. District Student Services would like zero units of separation only if the degrees are the same (e.g., a student who already earned a Business Administration Associate of Science

degree attempting to earn a Business Administration Associate of Science for Transfer degree). They compromised that there would be zero units of separation for the same or related degrees. The latter term was not defined. District Student Services will keep track of cases that fall under the related degrees category.

(a) The committee discussed the impacts of this decision.

- 6) Roundtable P. Hopkins stated Chancellor Carroll released three frozen positions for hire at Miramar College: Aviation faculty, Medical Laboratory Technician faculty, and Chemistry Instructional Laboratory Technician.
